Our vision is for all older people to have the option to live in high quality Retirement Communities in their later years.

Retirement Communities maintain independence, foster friendships and ease loneliness – they create positive outcomes for older people and their families. They also provide a benefit to our public services, free up housing for all generations, and make a huge contribution to our health and social care economy. The Retirement Community sector

Retirement Communities are about more than bricks and mortar – and are also about more than care. They are about buying or renting high quality housing with a safety net of services to go along with it.

Still not sure what it is? You are not alone – communicating a clear vision of what our sector provides is one of the key challenges ARCO is currently engaged in. The sector is still in its infancy in the UK – only 0.6% of over 65s live in a Retirement Community.

If we were to reach only half the levels seen in other countries with more mature markets, we'd need to build around 250,000 homes by 2030, which is our vision. Doing so will require spending £70 billion along the way, so the opportunities are huge, and we need your input to make it happen.

About you

We have a huge opportunity to shape the policy landscape for one of the fastest growing and most exciting sectors in the UK. We need someone who will join our ambitious policy team as a policy and Government relations expert, capable of building the case for reform, developing a compelling body of evidence and persuading key decision makers to adopt our proposals to help improve the lives of hundreds of thousands of people.

We need someone with strong stakeholder engagement experience – having liaised and built relationships with both internal and external senior stakeholders, someone with an outstanding ability to produce research and policy reports, responses and briefings and someone with an ability to communicate effectively in support of this.

Purpose of the role

To play a big role in helping to improve the policy environment for the Retirement Community sector – so that our members can grow and provide good quality housing and care to hundreds of thousands more people. To help ARCO develop our political and policy relationships, impact and influence, and to help ARCO deliver on its objectives, including some support for our media and social media work and wider communications.

Benefits of the role

This role will give you the opportunity to meet and influence senior political and policy decision makers. It will give you the opportunity to take on significant levels of responsibility and to get far more exposure than would normally be associated with a role at this level. In addition you will get:

- 25 holiday days per year, excluding bank holidays and other times the office may be closed
- Some flexibility for home working and reasonable adjustments to working hours
- Employer pension contributions
- Opportunities for training and personal development

About us

We are a small team but we get things done, because everyone mucks in.

Because we're small, we all have the chance to experience and be involved in all aspects of the organisation's work. If you have a passion for hierarchy, legacy systems and an unwavering belief in never questioning the status quo – this role is not for you.

ARCO is seven years old, but we're pretty grown up – with 10 members of staff (including you), a network of 30+ operating members and 60+ affiliates, we provide sector-leading insight, events, and influence (our members describe us as "punching well above their weight").

Our members are a combination of private companies, charities, and housing associations – what unites us is a joint commitment to older people's wellbeing; providing choice, enabling independence, and delivering high-quality housing and services.

In the UK, sector regulation and legislation for Retirement Communities is still in its infancy. We believe that over time, regulation and legislation for our sector will (and needs to) develop. Therefore, ARCO has put in place its own Consumer Code, designed to drive up standards and consumer confidence. This represents an excellent starting point for future Retirement Community regulation in the UK. Of course, this also means that we need to engage with a wide network of stakeholders, including central government, local government, advocacy organisations, regulators and the media, while working with our current members and affiliates and recruiting new ones – we keep busy!

Key tasks of the role

1. Playing a key role in the delivery of ARCO's public affairs and policy function, including:

- a) Meeting senior stakeholders
- b) Preparing thought leadership reports
- c) Shaping Government and opposition policy
- d) Researching and preparing consultation responses
- e) Preparing briefing notes for stakeholders
- f) Representing ARCO at working groups

2. Contributing to ARCO's media strategy through:

- a) Contact with journalists
- b) Writing press releases
- c) Media monitoring
- d) Posting on social media

3. Other tasks and requirements:

- a) Supporting the delivery of ARCO's Vision 2030. This Vision and its components form the basis of ARCO's activities for the coming years. All ARCO team members are required to undertake any reasonable activities which will assist in the delivery of this Vision.
- b) Supporting the delivery of ARCO's annual conference and other key events.
- c) Being willing to travel during the course of your duties with possible overnight stays away from home.
- d) Undertaking any other duties commensurate with the purpose and remit of the post.
