

Our aim is a large scale, commercially viable and supportive housing offer that promotes independence, eliminates loneliness, and makes the last move in people's lives their best.

### What are Integrated Retirement Communities?



# What ARCO does for its Members

### Policy & Influence



Delivered through policy campaigning work with government Ministers, civil servants, local authorities, academic bodies, charities and other key stakeholders to influence the future shape of sector legislation.

We are building awareness of the sector and increasing its influence with the public and key decision makers through our work with the media, social media, political allies and consumer advocates. We are also supporting the work of the recently established cross-Government Older People's Housing Task Force to develop the regulation our sector needs to grow and to tackle barriers holding back supply.

Following two years of campaigning, ARCO is now seeing the formation of a cross Government Task Force for older people's housing as part of the Leveling up agenda.

#### Why we do it:

The key to the sector's expansion is consumer and investor confidence. Only by helping to create a legislative environment that formally recognises Integrated Retirement Communities as a unique asset class can we create the strong foundations on which the sector can grow.







### **Regulation & Compliance**

Delivered and driven by the ARCO Consumer Code with regular external assessments of members to ensure the best customer experience is achieved and that sector integrity and reputation is maintained.

We work continuously with our members and other stakeholders to develop, maintain and refine a regulatory environment for our sector that is fit for purpose both now and in the future.

#### Why we do it:

Consumer confidence via robust consumer protection is paramount to the success of our sector. We hope that the rigorous consumer standards that we set today will be adopted in future sector specific legislation. Until this legislation is passed we must self-regulate to drive, maintain and elevate standards. We seek to continuously improve in this arena.



### **Events & Collaboration**



Delivered through a regular series of thought-provoking events (live and digital) with specialist working groups, roundtables, seminars, research and reports.

We also collaborate with leading organisations in the adult social care sector via the Care Provider Alliance. We provide a focal point for sharing best practice, exchanging knowledge, collaboration and serve as a networking platform for both operators and commercial organisations who are currently operating in or want to operate in this sector.

#### Why we do it:

Our sector, our product, and our value offer are constantly evolving. # Our Impact and Reach in 2021-22

### **Older People's Housing Task Force**

There is consistent evidence from around the world that the growth of the older people's Housing-with-Care sector depends on suitable and effective sector specific legislation. In the UK this has been held back for years because policy responsibility for our sector is split across six different government departments and local government. To that end ARCO determined that there was a need for a coherent and joined up approach to our sector and a way of securing a clear direction from Government. This is why we spent two years advocating for and building up the evidence base for a cross-Government Task Force. To that end we released a number of thought leadership reports, secured over a thousand pieces of relevant media coverage including an open letter to the Prime Minister signed by 40 investors, charities, academics, older people's advocates and Parliamentarians, held a Westminster Hall Debate and secured the tabling of almost 200 Parliamentary Questions. As a result of these efforts we saw clear commitments to our Task Force in three Government White Papers in a month, most specifically in the Government's Levelling-up White Paper. This Task Force represents a once-in-a-generation opportunity to shape the way our sector grows, develops and is regulated. We are now working hard to inform its work so that it produces the best possible outcomes for older people, providing clarity and consumer protection as well as reassuring investors and operators and establishing IRCs as a key part of the housing and care systems in the UK.



### Securing Ministerial and Government backing

November 2021 saw the Care Minister, Gillian Keegan delivering her first speech in the role at the ARCO Conference. The Minister took the opportunity to heap praise on our sector and to set out the scale and impact the Government how sees our sector achieving in the coming decades. The Minister encouraged the sector to be ambitious and to seek to grow rapidly over the coming years – stating that this was essential in the context of the challenges the UK health system is facing.

In addition to this Lord Greenhalgh, the Housing Minister in the Lords and Stuart Andrew, the Housing Minister as well as his predecessor Chris Pincher have answered Parliamentary Questions with consistent affirmations of the role of our sector and statements of Government backing.

Despite frequent turnover of Ministers in recent years the sector can take great reassurance that these commitments have now been embedded as cross-Government policy in White Papers including the Social Care White Paper – which recognised the crucial role that housing plays in care, and in the Levellingup White Paper which answered ARCO's calls for a crossgovernment Task Force for the sector.

### Scottish Housing-with-Care Task Force

ARCO was delighted to work with Sovereign Property Partnership and numerous sector stakeholders, experts and operators to develop a comprehensive plan to tackle underprovision of IRCs in Scotland – concluding in June 2022 at an event in The Scottish Parliament. This event and report received cross-party backing in Scotland and is already being fed in to Scottish Government policy.

### Setting out the sector's policy priorities

Ahead of the cross-government Task Force which the Government launched in response to calls from ARCO we took the opportunity to set out the key policy issues and priorities for the sector in a series of briefing papers. These included positions on planning, social care, terminology, consumer protection and leasehold reform. These along with supporting evidence have been fed in to the Task Force and are helping to inform the work of this once-in-a-generation policy making body.

### **Influential reports**

We've published ground-breaking reports bringing new evidence and insights, and attracting widespread attention. In Autumn 2021 ARCO released an analysis of the quality and value of the care our sector provides, we followed this with the *Retirement Reconsidered report* based on the largest ever survey of older people's views on housing and care. In addition we supported the Mayhew Review which set out the extent of unmet demand for IRC provision throughout the UK and the scale our sector needs to reach to support the UK's wider social care and housing systems in the decades ahead.

### **Press and media**

We've secured hundreds of articles in national, regional and trade press, including on our report launches, the Mayhew Review, Retirement Reconsidered and the Task Force launch. We've also written a range of comment pieces drawing attention to the great work of our members.

# Our Key Objectives for 2022-23







With the IRC sector needing a more defined role in housing and social care policy and a more coherent approach from Government ARCO developed the idea for an Older People's Housing Task Force. We mobilised significant support from around the sector and allies to this end and spent the last two years securing the necessary commitments from Government. Earlier this year we got these commitments in three White Papers – most clearly in the Levelling Up White Paper.

Work has already started on this Task Force and ARCO is working hard to ensure that this once in a generation opportunity to shape the future of our sector is not missed. As such much of ARCO's policy and public affairs work in 2022-23 will be directed towards engaging with the Task Force to ensure it achieves the best outcomes possible for Housing-with-Care. This will include preparing research, evidence and briefing materials, liaising closely with Task Force members and officials, and publishing regular bulletins to evaluate the task force's work.

Having secured the Task Force through ARCO's public affairs efforts we are now determined to use this unique opportunity to help grow the Housing-with-Care sector through planning reform, strengthened consumer protection, a clear role in the social care sector and more, and ARCO's policy priority will be doing all we can to achieve these ends.



### Influencing political and media priorities

ARCO will continue to closely monitor and engage Parliamentary activity and try to shape relevant bills when they come forward. For example, we have been closely engaging with officials and wider stakeholders to ensure that the Levelling Up and Regeneration Bill recognises the crucial role that IRCs need to play in improving housing and care options for older people throughout the UK. We are also engaging extensively in ongoing Government policy work on social care and regulation, leasehold reform and planning. We will be working with our Parliamentary Supporters and allies to ensure that we maintain the political momentum we have built up around our model in recent years. This includes tabling hundreds of Parliamentary questions and securing interventions and debates in Parliament on our sector.

In addition to this we are increasingly prominent in national, local and specialist media as well as on LinkedIn and Twitter advocating for our policy positions and maintaining public pressure for the policy changes our sector needs. We are increasingly receiving support from our political allies and stakeholders in these efforts.




# Widening outreach

As the cross-government Task Force begins its work, we will continue to provide cutting-edge thought leadership work on the Housing-with-Care sector to bring new evidence and insights to light. This includes reports on the value of high-quality care in Housing-with-Care settings, The *Retirement Reconsidered report* based on largest ever UK survey amongst older people about their housing and care preferences, and supporting *The Mayhew Review* which has established for the first time the full picture of the scale that our sector needs to grow to in coming years in order to meet demand.

We also continue our thought leadership work by running roundtables and panel events to highlight the challenges and opportunities of our sector, contributing a range of written articles for media publications, and of course, through our *What Next? 2023* conference in July, at which high-level speakers will discuss the key issues for the Housing-with-Care sector. ARCO is proud to have a group of 30 Parliamentary supporters of our Vision 2030 including MPs and Peers from six different political parties and groups, in addition to nearly 200 Parliamentarians and key figures from across local government who work with us to support our sector and improve housing and care options for older people. Based on our increasing profile in all parts of the UK we intend to widen our support next year. We are once again organising frequent in-person panel events and roundtables inside and outside of Parliament to engage a big audience in the work of our sector and plan to expand our invitations to MPs, councillors and media to visit their local Integrated Retirement Communities again over the coming year. We are also constantly growing our media and social media reach, for instance through securing more coverage in national news outlets, and increasing our followings on Twitter and LinkedIn. It will be an important year for drawing on a wide base of support, and the significant public impact of The Mayhew Review and Retirement Reconsidered showed what can be achieved when we work with allies within and around the sector to make the case for IRCs playing an increased role in housing and social care provision.

# Membership Eligibility



Membership of ARCO is open to Operators whose communities meet the below eligibility criteria:

#### You must:

- (a) Provide Integrated Retirement Communities that are primarily for older people.
- (b) Offer self-contained accommodation that can be occupied with security of tenure.
- (c) Enable residents to take advantage of personal care that is delivered flexibly, usually by staff based on the premises.
- (d) Have staff available at the community 24 hours a day.
- (e) Make domestic services available for residents.
- (f) Make meals available in restaurants or dining areas.
- (g) Offer communal facilities and encourage an active social programme in the community.
- (h) Aim to offer people a home for life and to enable them to 'age in place'.






#### ARCO Standards & Regulation Programme

Our aim is to ensure that older people considering a move to an Integrated Retirement Community are provided with the information that they need upfront, and that their rights as consumers and as owners and residents are protected.

All ARCO Members must agree to abide by the Consumer Code and the Standards and Compliance Framework. ARCO membership, therefore, means that the Integrated Retirement Community operator has agreed to go beyond the legal requirements to ensure transparency in its marketing and sales practices, providing information on fees and charges to customers promptly. The Code also sets the core levels of service provision for ARCO members, and requires operators to treat consumers fairly.

Members are regularly assessed by independent assessors on behalf of ARCO to ensure that high standards are maintained. In addition, ARCO supports members to achieve compliance by providing workshops, training, and guidance materials.

ARCO's Standards and Regulation functions are overseen by the Standards Committee which is made up of senior officers of ARCO Approved Operators. The Committee confers Approved Operator status annually on members who have achieved compliance and works to promote high standards across the ARCO membership.



# Membership Types









**Approved Operators** are Full Members of ARCO who have been through the stringent standards assessment programme with at least one operational scheme and have formally achieved compliance against the ARCO Consumer Code and approved by the ARCO Board.

Only Approved Operators can stand for election onto the ARCO Board, and can use the Approved Operator logo.

ARCO Provisional & Prospective Members **Provisional Members** are organisations who already have one or more operational Integrated Retirement Community open to residents and potential residents. They are currently going through the assessment process to achieve compliance against the ARCO Consumer Code.

**Prospective Members** are organisations who are in the process of building or getting ready to open their doors to their first residents. They are actively marketing their community and selling units off plan. Prospective members work closely with the ARCO Compliance & Engagement Manager and our independent assessors to achieve full compliance before they open their doors to residents.

### ARCO Approved Operators, Provisional and Prospective Members are all subject to the Consumer Code.

Accelerators are organisations who are at various stages of developing and preparing their plans for the future opening and operation of an Integrated Retirement Community. Some of these organisations already have experience of the sector and have a new venture to expedite. Some are new entrants to the sector or come from similar 'operationally' focused businesses but are not familiar with the specific complexities of operating an Integrated Retirement Community.

The aim of the ARCO Accelerator Programme is to provide its members with access to knowledge, experience and know-how. ARCO acts as a signposting agency to professional services offered by ARCO Commercial Partners, acts as a mentoring agency by providing access to the management teams of some of the most experienced operators in the UK, and provides a series of curated seminars and events that promote accelerated learning and importantly how to avoid the potential pitfalls. Our aim is for our Accelerators to be equipped for success and for them to have the potential to be the operators of the future.

# Membership Fees



### Membership Fees for Approved Operators, Provisional and Prospective Members are made up of three parts:

#### **Base fee**

The base fee per registered unit is **£10.60 (plus VAT)**. A unit is defined as one apartment or house within an Integrated Retirement Community.

There is a collar (i.e., minimum payment, 500 units) of **£5,300 (plus VAT)** and a cap (i.e., maximum payment, 1000 units) **£10,600 (plus VAT)**, per year, regardless of the number of units registered.

For operators who register between 501 and 999 units, their base fee will be calculated from the total number of units x **£10.60 (plus VAT)**.

#### **Growth fee**

In 2019/20 the ARCO Board levelled up their investment in the sector and moved to grow ARCO's reach and impact. At the same time the Board recognised that ARCO's strength comes from its diverse membership. To reflect ARCO's breadth of membership; from charitable providers, housing associations to private providers, each member's fees are now linked to their customer offer and plans for growth.

#### These fees, set by the ARCO Board, take a number of factors into account:

- Whether operators are offering schemes for affordable rent, or the private payer market (or a combination of both).
- The size of their existing operations in the Integrated Retirement Community sector.
- Whether they have plans for no, moderate or large-scale growth.
- How many assessments organisations will need to be undertaken based on the size of their portfolio.

# While this means that membership fees for operating members will be tailored to individual organisations, the following provides an indication of ARCO's subscription fees, which funds the work of the association going forward:

- Small provider of affordable rented extra care schemes with limited or no growth plans: c. £3,075 £8,200 (plus VAT).
- Medium sized providers of mixed tenure schemes with moderate expansion plans: **£10,250 £20,500 (plus VAT).**
- Providers of private payer Integrated Retirement Communities with considerable growth ambitions: **£20,500 £30,750 (plus VAT)**.

#### **Assessment fees**

**Approved Operators:** There is a fee of **£1,590 (plus VAT)** per onsite assessment and **£1,470 (plus VAT)** per online assessment under the Consumer Code.

The number of assessments for full members are as follows:

An organisation with only one scheme will need to have an assessment every two years. At least one assessment of each member must take place onsite; the remainder can take place online.

### For Prospective Members:

An 'Enabling Compliance' assessment will need to be undertaken during the development of any Integrated Retirement Communities. This is a more detailed assessment that provides more support to the member, which aims to ensure that ARCO's requirements for standards and compliance are met before marketing and sales take place. This type of assessment can require more than one meeting and usually focuses on the following key areas:

- **1** Marketing materials, website and advertisements (before reservations are taken).
- 2 Leases and contracts.

A further assessment of the first community to open will be required, which takes place shortly before residents move in, covering the entire scheme.

### For Provisional Members:

One 'Enabling Compliance' assessment will need to be undertaken during the first year, regardless of the number of schemes being registered. This type of assessment can require more than one meeting and will ensure that existing processes and policies are in line with the Consumer Code, as well as allowing time for any revisions that need to be agreed.

The fee for introductory 'Enabling Compliance' assessments is **£2,450** (**plus VAT**) (assuming only one site is assessed).

There may be an additional cost if significant negotiations or face to face meetings are needed to agree compliance with the external assessor, though this is not anticipated in most situations.

### **Accelerator Fees**

• Accelerator membership is £10,250 (plus VAT) per year

Approved Operators are Members of ARCO who have been through the stringent standards assessment programme with at least one scheme and have been formally 'signed off' as being compliant against the ARCO Consumer Code. These members typically have between 1-30 operational schemes.



### **ARCO Provisional & Prospective Members**

**Provisional Members** are organisations who already have one or more operational Integrated Retirement Community open to residents and potential residents. They are currently going through the assessment process to achieve compliance against the ARCO Consumer Code.

**Prospective Members** are organisations who are in the process of building or getting ready to open their doors to their first residents. They are actively marketing their community and selling units off plan. Prospective members work closely with the ARCO Compliance & Engagement Manager and external assessors to achieve full compliance before they open their doors to residents.





### **ARCO Accelerator Programme**

Accelerators are organisations who are at various stages of developing and preparing their plans for the future opening and operation of a Integrated Retirement Community. Some of these organisations already have experience of the sector and have a new venture to expedite. Some are new entrants to the sector or come from similar 'operationally' focused businesses but are not familiar with the specific complexities of operating an Integrated Retirement Community.

### Vision 2030

We know that there is already huge unmet demand for more Integrated Retirement Communities to provide housing, support and care for older people in the UK.

With an ageing population, these demands will become more pronounced and we believe that the UK's health and social care systems need more of the unique support that Integrated Retirement Communities provide.

This sector has already been growing and currently provides Integrated Retirement Communities for 75,000 people. However, by international standards, our sector is still in its infancy.

Our ambition is for 250,000 people to have the opportunity to live in Integrated Retirement Communities by 2030.

Making this vision a reality will require a persistent focus on our customers and our services whilst increasing supply.

Vision 2030 focuses on the following 10 key areas:



### A clear customer proposition

The Integrated Retirement Community sector offers a wide range of innovative solutions that address the housing, care and support needs of our ageing population. However, the range of terms used to describe the offer can be confusing for customers and stakeholders alike. For example, the absence of a clear definition makes it difficult for policymakers to come up with sector specific recommendations, while consumers struggle to locate Integrated Retirement Communities in the wider social care and housing landscape. The development of a clear and well communicated customer proposition is therefore paramount for the expansion of the sector.



In the absence of sector-specific legislation, ARCO members have made a commitment to abide by standards that go over and above what the (fragmented) legal framework for the sector stipulates. The ARCO Consumer Code, our Standards and Compliance Framework, and our assessment programme are designed to ensure a high-quality offer for customers and residents, through identifying issues before they occur. Consumers can have confidence that ARCO Approved Operators are committed to providing a quality service. Because it focuses on best practice and continually evolving higher standards, it is our view that self-regulation will complement (rather than be replaced by) sector-specific legislation once this is introduced.



### Sector-specific legislation

Currently, a patchwork of legislation governs the Integrated Retirement Community sector. Unlike in other countries, there is no sector-specific legislation that sets clear expectations for both residents and operators. In order to give statutory backing to new models of tenure, and provide certainty and consumer protection to 250,000 older people, sector-specific legislation will need to be introduced over the coming years. In this way, rather than being an additional burden on the sector, a smart 21st century system of regulation will play its part in ensuring a thriving sector and aspirational living environments for residents.



Expanding the Integrated Retirement Community sector will require a robust evidence base – to drive operational excellence, demonstrate effectiveness, ensure accountability and transparency to residents and their families, and to underpin investment and funding decisions. We will collect, analyse and publish sector-specific information via ARCO Analytics, on our website and in regular reports, ensuring that decisions about where to live or whether to invest can be made based on robust data and information.



The Integrated Retirement Community sector is a people business, and research shows that resident satisfaction is highly correlated with the quality of staff on the ground. Ensuring consistently high levels of care, service and support is critical. We are working on the challenge of effectively recruiting, training and retaining this workforce. We also need to increase the profile of this exciting and rewarding sector, and the important roles in it which provide a massive social benefit. We will be developing workforce strategies and coordinated approaches to training and retention via the ARCO Academy.



### Enhanced health and wellbeing

People are living longer – 11.8 million people aged over 65 currently live in the UK, and the number of people aged over 75 is projected to double in the next 30 years. Unfortunately, healthy life expectancy has not kept up with life expectancy in general, meaning that older people in the UK increasingly live into old age with (potentially multiple) conditions which may impact on their independence and quality of life. Research has shown that Integrated Retirement Communities keep people healthy for longer, can reduce and even reverse frailty, and provide more effective and cost-efficient delivery of health and care, and we will be focusing on ways to increase these positive impacts.

#### Progress

As we entered into the 2020s we have been working at turning ARCO's strategic vision into an achievable and demonstrable reality. At the request of our board we have increased our focus on those areas where only ARCO is operating and can add value (e.g. sector specific legislation, effective self-regulation and a clear customer proposition). Our members and partners have generously provided additional resource for this activity.





### Sustainable funding streams

Our sector brings together housing, leisure as well as care and support services. Therefore, funding streams will by necessity be made up of a number of sources. In order to safeguard the expansion of the sector, it is vital that changes to funding, benefits, and legal arrangements are well balanced and do not have an adverse impact on residents' ability to move to and remain in Integrated Retirement Communities, or on operators' capacity to create sustainable business models and increase supply.



#### Clarity in the planning system

The UK planning system fails to adequately consider the housing and care needs of our ageing population. The current approach also lacks consistency in how Integrated Retirement Communities are classified, planned for and delivered (as the element of care and support delivery is often overlooked). This needs to change, and any future expansion of the sector will require the planning system to be much more consistent and clear about the role of Integrated Retirement Communities, giving local authorities the support and guidance they need to meet local demand.



Technology will continue to change and improve our lives, and has the capacity to enhance the customer experience and drive operational performance. We will continue to engage with researchers, start-ups, and technological experts who harness the power of both mainstream and cutting edge design solutions, including artificial intelligence and robotics, in order to deliver a truly outstanding customer offer, improve care and services, and ultimately improve the quality of residents' lives.



The Integrated Retirement Community sector currently uses tenure models that were not designed for integrated service delivery. This means that a leisure, hospitality, care, support and housing offer is often wrapped up in a real estate contract, for example via the leasehold system. We believe we need to follow the lead of other countries with advanced Integrated Retirement Community markets in creating more flexible forms of tenure. This would allow for high levels of clarity regarding the rights and responsibilities of both residents and operators. It should give residents a clearer and enforceable set of rights, and would allow for the relationship between the operator and resident to evolve and be updated over time. It should also enable a more flexible approach that can be tailored to suit the needs of individual residents.

#### How do you define an Integrated Retirement Community for the purposes of membership, for instance, what are the requirements about care provision and 24-hour staffing?

Care provision and 24-hour staffing is a key differentiator between a Housing-with-Care offer and a retirement housing proposition.

For an Integrated Retirement Community to qualify for ARCO membership, it must meet all of our eligibility criteria which are listed on page 14 of this brochure and in the ARCO Consumer Code.

#### My organisation is not currently a member, but we are thinking about joining, what should we do?

#### I'm a developer building an Integrated Retirement Community, but someone else is going to operate it. Can we join?

ARCO is made up of operators of Integrated Retirement Communities, as we believe that the long-term operational model is the most likely to provide customers with the full benefits that Integrated Retirement Communities have to offer. Therefore, you would not be eligible to join as the developer only, but we are always interested in speaking to people involved in new Integrated Retirement Communities in the UK.

I am interested in your work and in Housing-with-Care, but my organisation does not run or operate Integrated Retirement Communities in the UK, how can we get involved with ARCO?

If you not operating, preparing to operate or considering operating an Integrated Retirement Community in the UK, then ARCO Membership is not an option. We do however have Commercial Partnership opportunities for organisations working within the sector and would be delighted to consider whether a partnership or affiliation relationship would be beneficial. ARCO Approved Operators, Prospective and Provisional members are all subject to the ARCO Consumer Code and must agree to be bound by the Standards and Compliance Framework including taking part in annual assessments.

ARCO Accelerators are organisations that are in the process of developing their customer offer and are not currently operating or marketing to sell off plan. Whilst Accelerators are not bound by the Standards and Compliance Framework, we do ask that they sign up to our Declaration of Shared Values which provides confidence to all ARCO's members and other associates that all other organisations involved with ARCO are trustworthy, ethical, and conduct their business with integrity, in alignment with our shared values.
