We seek to elevate and drive quality standards; help shape a fit for purpose legislative environment; and grow the industry for the mutual benefit of all stakeholders.

ARCO's aim is to see a sustainable, universally understood, and wellregulated Integrated Retirement Community sector in the UK. Our aim is a large scale, commercially viable and supportive housing offer that promotes independence, eliminates loneliness, and makes the last move in people's lives their best.

What are Integrated Retirement Communities?



Living Options for Older People

Integrated Retirement Communities are the fast-emerging 'lifestyle option' for older people. The chart below shows how they sit between Retirement Housing where minimal support is provided, and Care Homes where there is a high level of dependence:

We build the case for changes we want to see in areas such as planning and consumer protection. We also deliver the 'building blocks' of change - raising the sector's profile, ensuring it has a seat at the table when policy changes are proposed and building the evidence of what the sector can do for older people and society.

The key to the sector's expansion is consumer and investor confidence. Only by helping to create a legislative environment that formally recognises Integrated Retirement Communities as a unique asset class can we create the strong foundations on which the sector can grow.

We hope that the rigorous consumer standards that we set today will be adopted in future sector specific legislation. Until this legislation is passed we must self-regulate to drive, maintain and elevate standards. We seek to continuously improve in this arena.




















Our Impact and Reach in 2022-23

Older People's Housing Task Force

It finally happened! A full three years after ARCO started its campaign for a cross-departmental Older People's Housing Task Force, and after countless Parliamentary Questions and letters to the Ministers from ARCO, the Task Force was finally launched in May 2023 by the Ministers for Housing and Social Care.

Chaired by Professor Julienne Meyer, the Task Force comprises 18 people and will look how to increase supply and improve the housing options for older people in later life, and ways to unblock any challenges. The scope of its work focuses on public and private specialised and supported older people's housing, with a particular focus on the private market for those on middle incomes. The scope does not include care homes.

It did not take long for the Task Force to make recommendations that drive forward ARCO's

agenda. Professor Meyer used her speech at the start of the ARCO conference to launch the first two formal recommendations of the Task Force:

- "We recommend that the government implements measures to protect consumers from hidden event fees, as soon as possible, based on recommendations developed by the Law Commission in 2017, and accepted by government in 2019.
- We recommend that the government ensures that older people's housing is given due consideration and prominence in the forthcoming revisions of the National Planning Policy Framework."

The Task Force is due to complete its work by the summer of 2024, and ARCO will strive hard to support its work.





ARCO Manifesto

With a General Election expected in 2024, ARCO published its pre-election manifesto for older people's housing in June 2023 setting out our policy priorities and the story of the sector.

The manifesto was launched at an event in the House of Commons with a speech from the Shadow Care Minster and dozens of Parliamentarians in attendance.

The report argues that a shortage of Integrated Retirement Communities (IRCs) and lack of support for the sector is resulting in thousands of people in late old age experiencing unnecessary ill-health, loneliness and loss of independence, as well as expensive long-term care fees.

The manifesto sets out an ambition for politicians: every older person should have the option of living in an IRC, wherever they live and whatever their resources.

Following the launch event, the ARCO team were subsequently invited in to brief Number 10 officials on the manifesto, and we will continue to push its messages and arguments far and wide in the run up to the next election.

Securing government support for the sector

A key job of the ARCO policy team is to continually make and remake the arguments around the benefits of the IRC sector for public policy and society.

After huge Ministerial turnover in recent years, we have worked closely with the office of Rachel Maclean MP, Minister for Housing following her appointment in February 2023, providing briefings and other support.

We were delighted when the Minister accepted our invitation to address ARCO's annual conference in central London in July 2023, and the clear enthusiasm she displayed for the sector.

She told Members and other delegates:

"Specialist retirement housing can play a hugely valuable role in helping people to remain living independently for longer; feel healthier, and ultimately to feel more connected to their communities.

A great example is the ExtraCare Charitable Trust's Shenley Wood retirement village, where 300 homes are available for purchase, shared ownership and rent.

Its fantastic array of facilities, clubs, and social opportunities support independent living while allowing individuals to pick up old pastimes and try new hobbies surrounded by neighbours-turned-friends."

Ensuring the right evidence

Making the case for the Integrated Retirement Community sector requires setting out the right evidence, as well as the right arguments.

In November 2022, the ILC-UK published an ARCO-funded review by Professor Les Mayhew of City University, entitled 'Future Proofing Retirement Living – Easing the care and housing crises'. It argued that the Government must build 50,000 new homes for older people each year to tackle the UK's housing and social care crisis.

Professor Mayhew's commission this year drew on evidence and input from over forty experts, and highlighted the concrete steps the Government needs to take to reach the levels of older people's housing required, including:

- Reforming planning rules to make it easier to build housing suitable for later life
- Putting older people's housing on a level playing field with all other developments
- Cutting Stamp Duty so it is the same for last-time buyers as first-time buyers
- Ramping up the financial advice available for older people looking to move

In a subsequent consultation document on changes to national planning guidelines, the government described the report as "important work... on meeting the challenges of our ageing population."

Our Key Objectives for 2023-24

It's a hugely exciting time for ARCO's policy, influencing and communications work.

Older People's Housing Task Force

Following a three-year campaign spearheaded by ARCO, the Older People's Housing Task launched in summer 2023.

ARCO will be making the most of the historic opportunity, and has already secured early recommendations from the Task Force that support ARCO's agenda for the government to:

- implement measures to protect consumers from hidden event fees, as soon as possible, based on recommendations developed by the Law Commission in 2017, and accepted by government in 2019.
- ensure that older people's housing is given due consideration and prominence in the forthcoming revisions of the National Planning Policy Framework.

ARCO will be supporting the Task Force's call for evidence and research, working with our Members and Partners to make the case for change and the clear role our sector must play in solving the housing and social care crisis in the UK.

General Election 2024

The next UK General Election is widely expected to take place from May 2024 onward. The ARCO Policy and Communications team will be focused on ensuring that Older People's Housing is given the prominence it deserves in the run-up to the election, as well as building relationships with the large slate of new MPs who are expected to be elected for the first time.

ARCO published its pre-election Manifesto 'An IRC in Every Town' in June 2023 at an event with the Shadow Care Minister in the House of Commons. We will ensure the IRC sector has the profile it deserves and will be arguing that every older person should have the option of living in an IRC, wherever they live and whatever their resources.

The Policy and Communications team will be attending all the major Party Conferences in the run up to the election, and running Fringe events with the Fabian Society, a public policy think-tank, who recently recognised in their June 2023 report on social care reform that: *"For older people, housing with care and integrated retirement communities offer much more support than traditional sheltered housing."*







Influencing political and media priorities

The voice of the sector

ARCO will continue to closely monitor and engage Parliamentary activity and try to shape relevant bills when they come forward. For example, we have been closely engaging with officials and wider stakeholders to ensure that the Levelling Up and Regeneration Bill recognises the crucial role that IRCs need to play in improving housing and care options for older people throughout the UK.

We are also engaging extensively in ongoing government policy work on housing and social care and regulation, leasehold reform and planning. We will be working with our Parliamentary Supporters and allies to ensure that we maintain the political momentum we have built up around our model in recent years. This includes tabling hundreds of Parliamentary questions and securing interventions and debates in Parliament on our sector.

In addition to this we are increasingly prominent in national, local and specialist media as well as on LinkedIn and X (Twitter) advocating for our policy positions and maintaining public pressure for the policy changes our sector needs. We are increasingly receiving support from our political allies and stakeholders in these efforts, and have seen our social media posts liked and shared by key figures such as the Housing Minister and the Chair of the Older People's Housing Task Force. ARCO will continue to submit responses to consultations from government and other organisations to argue the case for the sector, protect the interests of Members and ensure their voice is heard.

In recent times, this has included consultations on topics as diverse as the Infrastructure Levy, Building Safety Levy, viability assessments, shared ownership and the national planning policy framework.

We are also working with organisations to improve how the planning system works for IRCs. For example, we are working with the Building Cost Information Service (BCIS) to create a separate category in their cost database for IRCs, and Homes England on how they can support the sector.


We will also continue to grow our social media platforms and develop new awareness strategies to widen our reach and raise awareness of the benefits of IRCs across both the sector and customers in the UK.







The Integrated Retirement Community sector are committed to providing **250,000** people in the UK with the option of living in Integrated Retirement Communities by **2030**. To make this vision a reality, we will need to focus on 10 priority areas for our sector.





Membership Eligibility

Membership of ARCO is open to IRC Operators who maintain an onsite presence at their registered communities. Membership is not open to developers, freeholders or landlords of IRCs who do not also manage the operations and service provision in their communities directly or through another entity in their corporate group, unless the operating entity is itself a Member of ARCO.

Registered communities must meet the below eligibility criteria:

You must:

- (a) Provide Integrated Retirement Communities that are primarily for older people.
- (b) Offer self-contained accommodation that can be occupied with security of tenure.
- (c) Enable residents to take advantage of personal care that is delivered flexibly, usually by staff based on the premises.
- (d) Have staff available at the community 24 hours a day.
- (e) Make domestic services available for residents.
- (f) Make meals available in restaurants or <u>dining a</u>reas.
- (g) Offer communal facilities and encourage an active social programme in the community.
- (h) Aim to offer people a home for life and to enable them to 'age in place'.





ARCO Standards & Regulation Programme

Our aim is to ensure that older people considering a move to an Integrated Retirement Community are provided with the information that they need upfront, and that their rights as consumers and as owners and residents are protected.

All ARCO Members must agree to abide by the Consumer Code and the Standards and Compliance Framework. ARCO membership, therefore, means that the Integrated Retirement Community operator has agreed to go beyond the legal requirements to ensure transparency in its marketing and sales practices, providing information on fees and charges to customers promptly. The Code also sets the core levels of service provision for ARCO Members, and requires operators to treat consumers fairly.

Members are regularly assessed by independent assessors on behalf of ARCO to ensure that high standards are maintained. In addition, ARCO supports Members to achieve compliance by providing workshops, training, and guidance materials.

ARCO's Standards and Regulation functions are overseen by the ARCO Standards Committee. The Committee confers Approved Operator status annually on Members who have achieved compliance and works to promote high standards across the ARCO membership.

ARCO APPROVED OPERATOR **Approved Operators** are Full Members of ARCO who have been through the stringent standards assessment programme with at least one operational scheme and have formally achieved compliance against the ARCO Consumer Code and been approved by the ARCO Board.

Only Approved Operators can stand for election onto the ARCO Board, attend Leadership Forum meetings and can use the Approved Operator logo.

ARCO Provisional & Prospective Members **Provisional Members** are organisations who already have one or more operational Integrated Retirement Community open to residents and potential residents. They are currently going through the assessment process to achieve compliance against the ARCO Consumer Code.

Prospective Members are organisations who are in the process of building their first IRC, or getting ready to open their doors to their first residents. They are actively marketing their community and selling units off plan. Prospective Members work closely with the ARCO Compliance Engagement Manager and our independent assessors to achieve full compliance before they open their doors to residents.

ARCO Approved Operators, Provisional and Prospective Members are all subject to the Consumer Code.

Accelerators are organisations who are exploring and developing their Integrated Retirement Community offer with a view to operate in the future. They do not currently operate or actively market to customers.

ARCO Accelerator Programme Organisations taking part in the programme may already have experience of the sector (e.g. a care home operator) and are looking at expanding their offer to include IRCs. Some are new entrants to the sector or come from similar operationally focused businesses (e.g. hotels, student accommodation) but are not familiar with the specific complexities of operating an IRC.

The Accelerator Programme provides its Members with access to knowledge, industry experience, and know-how. ARCO acts as a mentoring agency by providing access to the management teams of some of the most experienced operators in the UK and signposts to many professional services through the commercial partnership network. Through a series of curated events that promote accelerated learning (including how to avoid the pitfalls) our aim is for Accelerators to be equipped for success and for them to be the IRC operators of the future.





I'm a developer building an Integrated Retirement Community, but someone else is going to operate it. Can we join?

Therefore, you would not be eligible to join as the developer only, but we are always interested in speaking to people involved in new Integrated Retirement Communities in the UK.

I am interested in your work and in Housing-with-Care, but my organisation does not run or operate Integrated Retirement Communities in the UK, how can we get involved with ARCO?

If you not operating, preparing to operate or considering operating an Integrated Retirement Community in the UK, then ARCO Membership is not an option.
